- 3. The instructor's commands and or directions are to be obeyed at all times during the training program.
- 4. Failure to comply with all instructions, guidelines and or directions given during training will result in expulsion form the training program and if in failing to follow the instructor's directions physical injury and or damage to property of another road user is caused, THE LEARNER DRIVING SCHOOL will demand that the student cover all costs not covered under the School's auto insurance policy.

PERSONAL INJURY

I understand that the trainee driving program is practical in nature and involves the risk of personal injury.

LIABILITY FOR STUDENT INJURIES

It is agreed that the LEARNER DRIVING SCHOOL will not be liable for any injuries sustained by any student, which was caused by a failure to comply, in a timely manner, with all directions and guideline given by the instructor.

THE LEARNER DRIVING SCHOOL GENERAL RULES AND REGULATIONS

- 1. Student must use appropriate foot ware (sneakers, boots or sandals with straps around the heel) No flip- flops or slippers.
- 2. Students MUST NOT use any illegal or legal substances that will impair their ability to operate the training vehicle safely. Failure to comply with this rule will result in expulsion from the school's trainee driving program.
- 3. All fees must be paid at the time of enrollment, unless some special payment plan has been agreed upon by management and the student.
- 4. Students must observe and comply with all road safety rules and signs.
- 5. Students must obey the driving instructors directions at all times.
- 6. Students MUST have their Learner's Driving Permit during ALL Class sessions.
- 7. Students must dress appropriately, to come to class.
